2017 Strategic Goals

1. Confirm and train at least 16 regular pick leaders for the 2017 season before June. Board Members to do at least 2 Pick Leads each throughout the season
2. Complete at least 60 picks throughout season
3. Maintain one Outreach Event per month from April until October (7 total). Board Member attendance mandatory at each event, must commit to at least one Outreach event each

4. Events: Kick Off Party, Movie Screening Fundraiser (let's make it big!), Season Wrap Up Party
5. Create and maintain 3 formal Committees with mandatory Board Member involvement and recruit Volunteers to join committees (titles: Fundraising/Marketing/Operations)
6. Amend and grow Pruning Social Enterprise expectations, standards, and policies. Look for more local landscapers to partner on with this
7. Look into starting a cider social enterprise with a local cider brewery
8. Implement Volunteer Management software for communicating with Volunteers and scheduling picks and events, potentially 'Nation Builder'. Work on updating active Volunteer contact information
9. Diversify funding streams so not reliant on gaming grant, build community partnerships like those with Whole Foods to increase donations
10. Outreach kit updated and switched to backpack with wheels for easy transportation to events
11. Complete more workshops regularly and promote/market workshops at least one month in advance; and implement new household/garden waste reduction workshop (workshops: Canning = 1/2, jam = 1/2, pruning = 2, waste reduction = 1/2)
12. Amend and edit VFTP Constitution and by-laws to reflect new provincial guidelines for 2018
